Bids will be opened in the presence of Bidders' representatives who choose to attend at 1:00 PM on 2077/12/01 (14 March, 2021) (or as per the date adjusted by e-GP System) at the office of Chhathar Jorpati Rural Municipality Jorpati, Dhankuta. Non-attendance of any or all the Bidder's representatives shall not hinder opening of the Bids.
- 6. The bid must be accompanied by Original Voucher of Bid Security as stated in the table above for each contract deposited at Nepal Bangladesh Bank Ltd. Similarly, the contract signing shall take place after the approval of the Master Procurement Plan (MPP) of the project from the concerned authority.
- 9. After the completion of evaluation of technical bids, all the technically substantially responsive bidders will be invited to attend the opening of price bids. The time, date and place of opening of price bids shall be notified in writing and/or by publishing notice.
